(Copy of bio-data should be attached with self-attested photocopies of relevant documents and one latest passport size photograph). Candidates appearing for the interview will not be paid any TA/DA.

Selected candidates shall be required to join immediately. The decision of the interview panel shall be final and binding.

After recruitment, if candidate wants to discontinue working, within the minimum notice period of 1 month, one month salary will be forfeited.

In case the candidate discontinue to work within 3 months of appointment then the next candidate in the rank as per interview panel may be given opportunity. Beyond 3 months, fresh advertisement will be floated.
