- 1) Reservation for PWD/ Other reserved categories will be executed as per Central Government Rule.
- 2) Age relaxation for SC/ST/OBC /Ex-servicemen/PWD will be as per rule
- 3) Candidates seeking reservation/Age relaxation benefits under SC/ST/OBC/PWD category must ensure that they are entitled to such reservation as per eligibility prescribed in the Notice and as per the instructions issued by Govt. of India. They should also be in possession of the certificates in the prescribed format of Govt. of India in support of their claim. Candidates claiming reservation/ age relaxation under OBC Category should submit the OBC Certificate given at Annexure -"B" prescribed vide Govt. of India, Department of Personal and Training OM No. 36012/22/93-Estt.(SCT) dated 15.11.93 along with Self Declaration given at Annexure "C" failing which the benefit of reservation or age relaxation will not be given.
- 4) ESI Corporation may increase or decrease or cancel filling up of any or all the post without assigning any reasons at the discretion of the Appointing Authority.
- 5) The recruitments are purely on contractual basis and selected candidates will have no claim for regularization of the service in the hospital.
- 6) Selected candidates will have to sign Agreement of Terms & Conditions on Rs.100/- Stamp paper to be purchased by the candidate prior to joining.
- 7) The selected specialists (Full Time) must have a professional indemnity policy which should cover the period as desired by ESIC. The policy is meant to cover professional liability falling on them as a result of error and omission committed by them while rendering professional service. The minimum sum assured should be Rs. 20 Lakhs for OBS & Gynaecologist, Rs. 10 Lakhs for General Medicine, Radiology and Chest (Pulm Medicine). Private practice will not be allowed for Senior Residents & Full Time Specialist on contract.
- 8) Interested candidates may appear for the Walk in interview as per given schedule along with their original documents & Xerox copies in support of their Date of Birth, Proof of Educational Qualification, Experience Certificates. Caste Certificates as per Govt. of India formats, Non-Creamy Layer Certificates as per Govt. of India format valid for the current year / latest in case

of OBC (Format Enclosed).They are advised to appear for interview with duly filled 'Annexure-A' which is available on website. Candidates are requested to present one hour before Interview timing mentioned against their specialty

- 9) In case of selection, Offer of appointment will be issued as per requirement
- 10) Candidates need to join duty within 07 days from the date of offer of appointment.
- 11) The selection is subject to the candidates proving their medical fitness.
- 12) No accommodation facility is provided by ESIC for contractual engagements.
- 13) For Senior Residents (3 year on contract basis) & Full Time Specialist On 1 Year Contract: A Security deposit of Rs.10,000/- by way of Demand Draft drawn on any nationalized bank & payable at Pune has to be submitted at the time of joining by successful candidates which would be forfeited towards administrative expenses if the candidate resigns without notice.
- 14) No TA/DA will be admissible either for walk in interview or joining the post.
- 15) The candidates appointed under PWD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC/UR.
- 16) The decision of the selection board will be final on all aspects of selection and no further correspondence will be entertained under any circumstance.
- 17) Candidates who have already worked as SR for 3 years after PG under central Residency scheme in any govt. Organization are not eligible to apply for the post of Senior Residents on contract basis under 3 Year Senior Residency Scheme.
