2. 0 Essential Educational Qualifications and Eligibility:

- 2.1 Educational Qualification: Graduate Degree in General Streams (such as B.Sc./B.Com./B.A.) from the recognized University.
- 2.2 A candidate is not eligible to undergo apprenticeship training if the gap is more than two years.
- 2.3 If the gap between the date of declaration of result and date of commencement of training is more than one year, an affidavit on stamp paper duly signed by Magistrate/Notary has to be submitted by the Apprentices, Mater of the affidavit will remain same as of declaration in the format given in Para 16.0 below.

- (tie case), the candidates with older age shall be preferred.
