Minimum Educational Qualification: Having Degree/Diploma in any discipline from any recognized university.

Duration: Initially for a period of SIX MONTHS. The tenure can be extended as per the requirements/performance of the retired official and at the sole discretion of IRCTC. The re-engagement can be terminated pre-maturely on One month's notice by either side. However, IRCTC can cancel the engagement at any time without providing any reason for it.

Remuneration: The remuneration of consultants shall be admissible arrived at by deducting the basic pension from the Pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contract. There will be no annual increment/percentage increase during the contract period.
